Bus Pick-Up Rules and Regulations are as follow:

- Transportation costs \$50.00 per month per child. Payments must be made on the **1st of every month** or you must have pre-arranged an installment plan. Participants who have not paid on time will be dropped from the program. Any member with an outstanding balance at time of membership renewal will not be able to renew until payment is made.
- Payment of transportation fees reserves a spot on the bus. There are no refunds for periods of time the child does not use the transportation program.
- Parents must notify the club by **12:00pm** if your child doesn't need pick up. **Failure to do so will result in your child being removed from the transportation program.**
- If a member misses the bus, they can be picked up by the Boys & Girls Club of Pasadena by calling the appropriate branch. However, members missing the bus will assessed a "missed bus fee" of \$25.00 that must be paid before the member can return to the program.
- Participants must be current members of the Boys & Girls Club of Pasadena.
- Participants might be required to ride the bus at least 3-times per week depending on availability.
- Participants must abide by the rules of the Boys & Girls Club drivers and monitors at all times. **Failure to do so will result in your child being removed from the transportation program.**
- Horseplay or roughhousing are prohibited in the vans or buses. **Failure to comply will result in your child being removed from the transportation program.**
- Eating or drinking are prohibited in the vans or buses. **Failure to comply will result in your child being removed from the transportation program.**
- We reserve the right to dismiss any member from the program who has displayed disciplinary problems while utilizing the transportation program.
- Transportation follows the Pasadena Unified School District schedule (i.e. when there is early dismissal, the Club picks up members early. When school is closed, there is no transportation). Exceptions to the PUSD schedule are unlikely. Transportation to or from summer school is never provided during the summer program.
